1. Light calculation

The present results have been prepared with great care on the basis of available information from the customer with the aid of standard market procedures and software systems (such as Dialux or Relux). Ushio has not carried out any own research, particularly with regards to the conditions on-site.

Ushio shall only provide a warranty for this elaboration to the extent that Ushio has taken the information provided by the customer without alteration, and has carried out the calculation based on this information on the basis of standard market procedures and software systems. Warranty claims on account of incorrect calculation shall only exist to the extent that Ushio provides a new, error-free calculation free of charge. Warranty claims shall become time-barred after 12 months from handing over the calculation to the customer. This is expressly not a planning or consulting service, but purely a standard calculation. This calculation must be checked and verified by the customer for its applicability to the specific situation. In this context, we refer to the services of light planning firms and subject-specific engineering companies.

There are possibly standards or other valid documents mentioned in the elaboration. Ushio warrants that the values determined have been determined in accordance with these standards. The determined values are based on calculations on calibrated lamps and luminaires, as well as fixed specifications regarding the geometries of the facility. In practice, deviations, also in larger dimensions, can occur. USHIO has not tested the suitability of the lamps and luminaires used. Warranty claims are excluded for the accuracy of the used luminaire and lamp data as well as for the usability of the determined values.
